#### **COMPETITION RULES**

Last updated WT Competition Rules & Interpretation, shall be applied.

#### COMPETITION SYSTEM - CONTEST TIME

- Single elimination tournament system.
- Best of three (3) system will be used.
- 3 (2) rounds of 2 minutes, 1-minute break between each round.
- Please also note that there will be **no finals** at the European Qualification Tournament.
- Semi Finals winners (NOC) get the quota.
- Bronze medal contests will be held instead, in order to determine the 3<sup>rd</sup> & 4<sup>th</sup> placed athletes.

The WT Technical Delegate has the authority to adjust the contest time as he sees fit.









#### **QUALIFICATION RULES FOR PARIS 2024**

- The top two (2) ranked men and women athletes of each weight category from Europe will qualify his/her NOC for the Olympic Games from the continental qualification tournament held in Europe making a total of eight (8) men and eight (8) women.
- Only NOCs which have secured quotas for less than two(2) athletes per gender through the WT Olympic Ranking or WT Grand Slam Champions Series can participate in the Continental Qualification Tournaments.
- If an NOC has qualified two(2) or more men and two(2) or more women athletes through the WT Olympic Ranking or WT Grand Slam Champions Series, it cannot participate in the Continental Qualification Tournament unless it declines quota places obtained through the WT Olympic Ranking or WT Grand Slam Champions Series in the respective gender.
- If an NOC qualified through the European Qualification Tournament declines the quota place or has not confirmed the use of the qualified place(s) by March 26th,2024 KST, upon receiving the confirmation letter from World Taekwondo on March 15th, 2024 KST, it will be reallocated to the NOC of the next highest ranked eligible athlete in the same weight category at the European Qualification Tournament, respecting the maximum number of athletes per NOC.
  - In the event that any of the qualified contestants was found to have committed a doping offense that constitutes a violation of any of the provisions of the Anti-Doping Code of the World Anti-Doping Agency and/or other appropriate antidoping codes, next highest ranked athlete in the same weight category at the European Continental Qualification Tournament will qualify his/her NOC a place.
  - The NOC of an athlete who has committed an anti-doping rules violation will lose the quota place obtained by the athlete. The maximum number of quota places for that the corresponding number of athletes who committed an offence shall reduce NOC.
- There is no finals in the European Qualification Tournament for Paris 2024 Olympic Games. NOC of the top 2 ranked athletes in each weight category will qualify to the Paris 2024 Olympic Games.









#### ATHLETE ELIGIBILITY REQUIREMENTS

- 1. Holder of a valid 2024 WT Global Athlete License; (GAL)
- 2. Member of the National team of a pertinent Member National Association, recognized by World Taekwondo, a letter from the federation may be requested.
- 3. Holder of the nationality of the pertinent Member National Association
- 4. Holder of Kukkiwon Dan certificate
- 5. An athlete in order to be eligible for participation must be born in 2007 or before. For those athletes that are not adults, a written consent must be submitted (please find enclosed on the last pages) at the registration, signed by one of the parents or legal guardians, accepting their participation and all parts of the official invitation.
- 6. In case of a Refugee athlete, the athlete must meet following requirements:
  - Must hold the Refugee Status, documented by UNHCR or
  - Refugee Status documented by national agency, e.g. Department of Foreign Affairs or related/responsible department of the residing country
  - Must present the residence status within country in Europe region
- 7. In case of a Individual Neutral Athlete(AIN), the athlete must
  - Obtain AIN Status, screened and confirmed by World Taekwondo
  - Only athlete with AIN GAL Number can participate

#### COACH ELIGIBILITY REQUIREMENTS

- 1. Minimum age of 18 years;
- 2. Holder of a valid 2024 WT Global Official License (GOL)
- 3. WT Coach Certificate Level I or above is required.
- 4. Coaches are not allowed to wear a Dobok.
- 5. In case of Individual Neutral Support Personnel participating as a coach must obtain AIN status, screened and confirmed by World Taekwondo. Only coaches with AIN GOL Number can participate.

#### DRESS CODE FOR COACHES

During the semi-finals & Bronze Medal Contest, all coaches are obliged to wear a formal outfit (suit/dress). During the preliminaries, quarter, coaches shall wear sportswear. Coaches that do not follow the dress code cannot enter the field of play.

#### Replacement of athletes

Athlete replacement after the registration deadline is only possible in case of injury or medical illness and shall be handled case by case by WT/ETU. Requests to replace athlete can be done by submitting the Late Athlete Replacement Form along with medical documents written by a medical professional in English to sport@worldtaekwondo.org no later than maximum 48 hours prior to the Head of Team Meeting.

#### PROOF OF PAYMENT REQUIREMENT

All teams are required to send proof of payment (copy of bank transfer) to <u>office@taekwondo-bulgaria.org</u> within one (1) week after registration in Simply Compete or submit it at the registration appointment booking platform. European Taekwondo Union has the right to delete sport entries from teams that do not send proof of payment from the system in order for other athletes to register and to prevent 'ghost athletes'.

Any athlete registering on-line who does not take part in the competition and who has not been removed from the entry list before the deadline (23rd February 2024), is liable for paying his/her entry-fee in full. (For any athlete not presenting at registration, his/her team or official will be liable for ensuring full payment has been received, prior to the team's participation). If a team does not show up at the event and has not requested a participation cancellation before the deadline, it will be requested to settle the payment of the entry fees in full (100%).

#### **NO REFUND**

European Taekwondo Union and/or the Organizing Committee do not refund entry fees paid.

#### ACCREDITATION CARD DISTRIBUTION

Registered teams only receive the athlete and official's accreditation cards if all financial obligations have been fulfilled. For all registered athletes, the entry fee has to be paid before the accreditation cards will be distributed to the respective team. Accreditation cards are personal and cannot be transferred. Misuse may be sanctioned.

#### SPORT EQUIPMENT

- KPNP Protector and Scoring System (PSS) including PSS Headgear will be used at the event.
- WT recognized mats will be used at the event.
- Athletes can only use WT recognized products while participating at the event. Wearing Dobok is not allowed.

- All participating athletes must wear WT-recognized Kyorugi competition uniform.









#### IDENTIFICATION OF NOC CODE AND MANUFACTURER

- National Flag shall be located between 3cm and 3.5cm below the right shoulder on Kyorugi Competition uniform.
- NOC Code must be printed at the back of the upper garment, font of the letters shall be ion bold "Verdana". NOC Code is a three-letter National Olympic Committee abbreviation, and it shall be printed at the back in black and centred at 5cm or higher from the bottom line of the upper garment within the size of 30cm width x 12cm height.
- Manufacturer's identifications (name, designation trademark, logo or any distinctive sign of the manufacturer) shall be located one for the top within 30cm<sup>2</sup> and between 3 to 3.5cm below the shoulder line of the left arm, one for bottoms within 30cm<sup>2</sup> located above the knee and center of the right leg, and one for Kyorugi belt within 6cm<sup>2</sup> at the end of the belt.

#### SPONSOR'S IDENTIFICATION

- ONE sponsor's identification (logo) is allowed to each of competition uniform's top and bottoms
- The sponsor's identification shall be located within 50cm<sup>2</sup> except the location of WT logo, manufacturer's identification, national flag, and NOC code.

#### FIELD OF PLAY REGULATIONS

By accepting a European Taekwondo Union accreditation card, all accredited persons agree to comply with the Field of Play regulations applicable at ETU events.

- 2 Certificates for the Qualified athletes-winners of Semi Final.
- 1 Bronze medal for the 3rd place athlete
- 1 Certificate for the 4th place athlete









#### ANTI-DOPING

- i. The WT Anti-Doping Rules, and where necessary the Code of the World Anti-Doping Agency, shall apply throughout the competitions.
- ii. Compulsory anti-doping tests will be carried out for selected medalists, while random tests will be conducted to the rest of the athletes. The WT and/or WADA may carry out random out-of-competition testing prior to the championships.
- iii. TUE (Therapeutic Use Exemption) Athletes who take any substance or medicine listed in the "Prohibited List" of the WT Anti-Doping Rules and Anti-Doping Code of World Anti-Doping Agency (WADA) for therapeutic purposes are requested to submit TUE applications via ADAMS, together with the required medical information. If you do not have an ADAMS account yet, please contact tue@ita.sport to have it set up.

#### INDEMNITIES

It is the responsibility of each registering team to ensure that their athletes and team officials have filled out the indemnification forms correctly and have duly signed them, thereby indemnifying WT, ETU, the Organizing Committee and all other officials and athletes from any claims of injuries, losses or otherwise arising in the course of participation at the European Qualification Tournament 2024 or any activities linked therewith. It is the responsibility of each registered team to ensure and guarantee that sufficient insurance coverage has been arranged for all athletes, team officials and other participants. Without sufficient insurance coverage, teams will not be allowed to compete.

Please fill out the Personal Indemnity Forms and return them to the Organizing Committee before 23<sup>rd</sup> February 2024. Each participant (athletes, team officials, etc.) has to fill out the indemnification form.

#### MEDICAL INSURANCE

All participating athletes, coaches, team officials, technical officials and participants at ETU events shall have mandatorily an international medical insurance that covers medical care (COVID included) and in case of emergency, repatriation to the country of origin, valid on the days present in the host country of the event. ETU nor the Organizing Committee shall be responsible to cover any medical costs incurred for medical treatment before, on or during the competition or repatriation in the broadest sense of the word. All relevant documents proving that such an insurance is present, including insurance policy papers, should be taken to the event in case a medical situation occurs. Each MNA, Team doctor or team medical staff must ensure their athletes and team officials have valid international health insurance that covers medical and emergency care at the designated hospitals in Bulgaria before arrival to the venue.









#### NON EU CITIZENS ENTRY REQUIREMENTS

Due to Bulgarian Government decision all participants at sport event need permission from the Bulgarian Ministry of Youth and Sport to enter in the country. The decision does not apply to the countries members of European Union, Schengen agreement and the following countries: San Marino, Principality of Andorra, Principality of Monaco, Vatican City, The United Kingdom of Great Britain and Northern Ireland, Georgia, Republic of Albania, Ukraine, Republic of North Macedonia, Republic of Serbia, Kosovo, Bosnia and Herzegovina, Montenegro, Republic of Moldova, Israel, Republic of Belarus and Republic of Turkey.

Representatives from other countries not listed above, need to contact: office@taekwondo-bulgaria.org in order to start the process for permission issuance.

The visa procedure is different for every country, please apply as soon as possible.

#### INTERNATIONAL REFEREES

World Taekwondo will appoint the International Referees. The appointed international Referees shall officiate at the European Qualification Tournament the following conditions shall apply:

- i. International Referees are required to pay for their own round-trip airfares.
- ii. The Organizing Committee shall cover the expenses for four (4) nights stay of room and board.
- iii. Check in: March 7<sup>th</sup> & Check out: March 11<sup>th</sup>. The Organizing Committee shall pay a per diem of USD \$150 to the selected International Referees for competition period (total 2 days: USD \$300 per referee). The Referee training will take place on March 8<sup>th</sup>, 09:00-18:00

### **Guideline on Refugee Athlete**



# For Continental Qualification Tournament Paris 2024 Olympic Games

- 1. The eligible refugee athlete must have official refugee status before the entry deadline of the pertinent continental qualification tournament, meaning that an athlete whose status is in process of examination will not be accepted to compete.
- 2. The refugee certificate issued by either governmental authorities of current residing country or the UNHCR will only be accepted.
- 3. In addition to the certificate, official endorsement letter from MNA of current residing country must be presented.
- 4. The refugee athletes must have either qualified to international standards in the recent past or have the potential to reach Olympic standard which shall be determine by one of following criteria:

- Be a medal winner (1<sup>st</sup> or 2<sup>nd</sup> or 3<sup>rd</sup> places) at any of the G ranked senior kyorugi competitions enlisted on the WT event calendar between June 1, 2022 and May 1, 2024.

- Be ranked within 20<sup>th</sup> place at least once in the WT World Ranking between June 1, 2022 and May 1, 2024.

- Have advanced to round of 16 or higher at WT World Taekwondo Championships between June 1, 2022 and May 1, 2024.

- Have advanced to quarter-finals or higher at two-year cycle Continental Taekwondo Championships held between June 1, 2022 and May 1, 2024.

- Be the 1<sup>st</sup> place of national taekwondo championships held between June 1, 2022 and May 1, 2024.

\*\* In case the athlete currently resides in a refugee camp, he/she can be exempted from article 3 & 4.

5. To register the refugee athlete, the above mentioned required documents shall be submitted to the WT Sport & Event Management Department
